Discussion:

1. Outdoor Fitness Program Grants
2. Unifirst Clothes service- The Highway has a 5 year contract with but would like to change companies.
3. Computer Outlet PC update- quote for 6 computers \$3,600. Computers in use can not be updated to Windows 11.
4. Re-look at Volney Multiplex Quote for 4 additional Cameras- \$3000- will relook at next meeting.
